

## ROUNDUP RIVER RANCH ADULT/FAMILY USER GROOUP RELEASE

### Acknowledgement of Risks, Activity Consent and Release

I understand that there are numerous risks involved in participating in any camp activities, including (for example) hiking, horseback riding, archery, challenge course, crafts, use of tools, boating, rafting, fishing and transportation. These activities will take place in an outdoor, mountainous environment. Some (but not all ) of the risks include: weather conditions, equipment malfunction, failure to understand and obey instructions, injury in connection with natural features or manmade objects, insect and animal contact, unstable surface conditions, water and subsurface conditions, contact with water, use of (or contact with) vehicles and watercraft, transportation accidents, and infection. A complete list of all risks is not possible. These and other risks can cause serious injury or death.

The following is required by Colorado law with respect to any equine activities:

**WARNING:** Under Colorado lawn, an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risk of equine activities, pursuant to section 13-21-119, Colorado Revised Statues.

On behalf of myself and my minor child (when applicable), I hereby release and waive any claims against Roundup River Ranch (and its affiliated organizations and sponsors, officers, directors, employees, volunteers and agents (the 'Camp Parties') arising from my child's use of any Roundup River Ranch facility or premises, and my child's participation in any program or activity sponsored, coordinated or supervised by Roundup River Ranch. I hereby agree to indemnify and hold harmless the Camp Parties with respect to any claim inconsistent with this Authorization and Release. I further agree to release, discharge and hold harmless the Camp Parties with respect to any medical expenses resulting from personal injuries sustained by myself or my child (when applicable) in connection with any camp activity or premises. I understand that this release and indemnification apply to transportation to or from Roundup River Ranch, or in connection with any of its activities. I hereby consent my and my child's (when applicable) participation in all activities at Roundup River Ranch.

We hereby notify Roundup River Ranch of the following exceptions or restrictions:

### Photo and Media Release

In order to share the story of Roundup River Ranch and bring our program to more and more families and children, we sometimes utilize staff or volunteer photographers, and news media to capture the magic of camp through photography and video. These photographs and videos will then be used in our printed materials, at special events, in advertising, and to promote public understanding and support for children with chronic of life-threatening illnesses. All photographers/videoographers are chaperoned by Roundup River Ranch staff at all times to ensure that what they record/photograph is appropriate and that their work does not disrupt the camp experience. Roundup River Ranch respects the privacy of its campers and does not allow unauthorized visitors to photograph the camp or campers. Parents/guardian consent is required before any child can appear in our materials. We respectfully request that you would consent you and your child (when applicable) appearing in photographs or videos while they are at camp. If you agree to you and your child (when applicable) appearing in video or photographs and agree to give Roundup River Ranch the rights associated with the use of such video or photographs, please check the appropriate box and sign the consent form below. If you do not wish you or your child (when applicable) to be included in materials, please check the appropriate box. To protect the privacy of children and families, only children who have a signed parental/guardian consent will be featured in our photos/videos. Please note that not all photos/videos will be used in promotional and other materials.
